

## **CONCRETE SERVICE FEES**

Normal Working Hours	Monday to Saturday 6.00am – 4.00pm
<b>Extra Cartage</b> \$2.20 per m³ per km	Unless otherwise specifically agreed, deliveries greater than 20 klms from a Midway concrete plant will incur an Extra Cartage charge of \$2.00 per km per m3 plus GST.
Waiting Time \$2.75 per minute during normal working hours	After arrival at the site, <b>20 min.</b> is allowed for discharging at the site for loads 3.0m3 or less and <b>30 min</b> is allowed for discharging at the site for loads 3.2m3 or above. Where a truck is detained by a customer on the site beyond 25 minutes, the following charges apply: \$2.50 Per minute during Normal Working Hours + GST \$4.50 Per minute outside of Normal Working Hours + GST
Short Load less than 3.2m³ Minimum Load	Unless approved by Midway all loads under 4m3 will be subject to 15% surcharge plus GST. A minimum fee of 1m3 will apply.
Customer Supplied Product Handling Fees \$15 per bag	The following charges will apply in relation to receival, storage, handling and manual addition of any additives or bagged products supplied by Midway or customer Supplied Products.
Accelerator Charges	Low dose \$9 per m3 including GST Medium dose \$14 per m3 including GST High dose \$17 per m3 including GST
<b>Washout Fee</b> \$33 per load	Where the customer requests addition of any colour, chemicals, fibres or other specialty additives to a load, a washout fee of \$30 per load + GST will apply.
Cancellation Fee \$1430 per order	Cancellation Fee applies when an order that is greater than 10m3 is cancelled after 3pm on the day prior \$1300 per order + GST
<b>Disposal Fee</b> \$173 per m3	Where surplus concrete is returned by the truck at the request of the customer, a Disposal Fee of \$150 per m3 + GST applies, after hours disposal fee of \$231+ GST applies
Acceptance	Placing an order after receiving a quotation as per Midway terms & conditions referred to in a quotation are deemed to be accepted.
Payments	Midway's payment terms are 30 days from the end of Month for account customers, as per Midway terms & conditions

After Hours Plant Opening Fee	If a plant is required to open or remain open outside "Normal Working Hours", a charge of \$3300 + GST for 4 hours will apply and part there of hourly after 4 hours will apply.
\$3630 for 4 hours	This charge is in addition to "After Hours Charges"
\$242 admin fee per load	Driver admin fee is paid per load in addition to plant opening fee when outside of "Normal Working Hours" \$220 per load + GST Please check with Midway for a project quotation
\$77 per half hour per truck or part there of	Where trucks are retained at the request of the customer outside "Normal Working Hours", for a period greater than 30 minutes before loading an additional charge will be incurred at the rate of \$70 per half hour per truck or part there of + GST
Sunday/Public Holiday Surcharges	Sunday & Public holidays incur an additional charge of \$35 per m3 + GST on all orders in addition to any other surcharges outlined
Concrete Testing Charges	The following charges are based on Testing performed during "Normal Working Hours".
\$380 Standard Compression Test	Includes: sampling, casting, testing, and reporting 1 extra cylinder (if Technician already on-site)
\$125 per Extra Cylinder	Includes: sampling, testing, and reporting of extra slump test (if technician already on-site)
\$120 per Extra Slump Test	Includes: sampling, testing, and reporting (if Technician already on site).
\$120 per Air & Yield Test	Includes sampling, casting minimum of 3 standard prisms and NATA Certified Report.
\$630 Drying Shrinkage Test	Normal Working Hours Charges plus 100% Refer times set out at "After Hours Charges" above.
\$826 After Hours Testing Charge	Includes: 1 slump test, casting minimum of 3 standard cylinders and NATA certified report.
Other Testing Requirements	Prices on Application
Delivery Dockets \$27.50 per copy	Midway will leave a copy of the delivery docket on-site with each delivery. The docket will be handed to the customer or its representative, it is the responsibility of the customer to retain and process those dockets as per their own accounting requirements. Duplicate copies of delivery dockets will be provided at cost of \$25 per docket + GST. It will be unacceptable to delay payment due to missing delivery dockets.
